

ALLY PREPARE A BUDGET REQUEST TO PROVIDE THE FUNDS AND POSITIONS REQUIRED TO FULFILL THIS RESPONSIBILITY.

(D) SUBJECT TO THE PROVISIONS OF SUBSECTION (C) ABOVE, THE MARYLAND EDUCATIONAL—CULTURAL TELEVISION COMMISSION SHALL HAVE FULL RESPONSIBILITY FOR AND CONTROL OVER THE PREPARATION, CONTENT AND PROGRAMMING OF ALL PROGRAMS FOR THE GENERAL PUBLIC.

(E) THE FACILITIES SHALL NOT BE USED FOR AND THE PROGRAMS SHALL NOT BE DEVOTED TO A PRESENTATION OF BIASED OR ONE-SIDED ASPECTS OF PARTISAN POLITICS, OR TO ADVOCATING OR OPPOSING ANY PRESENT OR PROSPECTIVE POLITICAL CANDIDACY, OR TO ADVOCATING OR OPPOSING ANY LEGISLATION CURRENTLY BEING CONSIDERED OR PREPARED. THE FACILITY MUST BE USED IN COMPLIANCE WITH THE RULES AND REGULATIONS OF THE FEDERAL COMMUNICATIONS COMMISSION.

(F) THE MARYLAND EDUCATIONAL—CULTURAL COMMISSION MAY RECEIVE AND EXPEND FOR THE PURPOSES OF THIS SUBTITLE SUCH GRANTS AND GIFTS AS MAY BE BUDGETED AND PROVIDED FOR IT.

(G) FOR THE FISCAL YEAR 1966-67, ANY PORTION OF THE FUNDS AND POSITIONS PROVIDED FOR THE PURPOSES SET FORTH IN THIS SECTION IN THE BUDGET OF THE STATE DEPARTMENT OF EDUCATION, AND WHICH ARE REQUIRED FOR THE MARYLAND EDUCATIONAL—CULTURAL TELEVISION COMMISSION TO FULFILL ITS RESPONSIBILITIES, SHALL BE TRANSFERRED TO THE COMMISSION AT THE DISCRETION OF THE BOARD OF PUBLIC WORKS.

SEC. 2. *And be it further enacted*, That this Act shall take effect July 1, 1966.
