

AMOUNT OF FIFTEEN HUNDRED DOLLARS (\$1,500.00). THE SHERIFF SHALL APPOINT A JAIL MATRON AT AN ANNUAL SALARY OF SIX HUNDRED DOLLARS (\$600.00).

SEC. 4. AND BE IT FURTHER ENACTED, THAT SECTION 255(E) OF ARTICLE 93 OF THE SAID CODE (1965 SUPPLEMENT), TITLE "TESTAMENTARY LAW," SUBTITLE "ORPHANS' COURT," BE AND IT IS HEREBY REPEALED AND RE-ENACTED, WITH AMENDMENTS, TO READ AS FOLLOWS:

(E) EACH OF THE JUDGES OF THE ORPHANS' COURT FOR CARROLL, QUEEN ANNE'S, SOMERSET, AND WORCESTER COUNTIES SHALL RECEIVE THE SUM OF EIGHT DOLLARS (\$8.00) FOR EVERY DAY'S ATTENDANCE UPON THE SESSIONS OF SAID COURT. THE JUDGES OF THE ORPHANS' COURT FOR WORCESTER COUNTY SHALL RECEIVE AN ALLOWANCE FOR TRAVELING EXPENSES OF EIGHT HUNDRED DOLLARS (\$800.00) PER YEAR. THE JUDGES OF THE ORPHANS' COURT FOR QUEEN ANNE'S COUNTY SHALL RECEIVE AN ALLOWANCE FOR TRAVELING EXPENSES OF \$750.00 PER YEAR. THE JUDGES OF THE ORPHANS' COURT FOR SOMERSET COUNTY SHALL RECEIVE AN ALLOWANCE OF FIFTEEN DOLLARS (\$15.00) FOR MILEAGE FOR EVERY DAY'S ATTENDANCE UPON THE SESSIONS OF SAID COURT.

SEC. 5. AND BE IT FURTHER ENACTED, THAT SECTION 51(R) OF ARTICLE 25 OF SAID CODE (1965 SUPPLEMENT), TITLE "COUNTY COMMISSIONERS," SUBTITLE "COUNTY TREASURER," BE AND IT IS HEREBY REPEALED AND RE-ENACTED WITH AMENDMENTS TO READ AS FOLLOWS:

(R) THE COUNTY TREASURER OF SOMERSET COUNTY SHALL RECEIVE AN ANNUAL SALARY OF NOT LESS THAN \$4,800 NOR MORE THAN \$5,400 IN THE DISCRETION OF THE COUNTY COMMISSIONERS. THE COUNTY TREASURER SHALL RECEIVE ANNUALLY THE SUM OF \$600.00 FOR EXPENSES.

SEC. 6. AND BE IT FURTHER ENACTED, THAT SECTION 9 OF THE CODE OF PUBLIC LOCAL LAWS OF SOMERSET COUNTY (1963 EDITION), BEING ARTICLE 20 OF THE CODE OF PUBLIC LOCAL LAWS OF SOMERSET COUNTY (1963 EDITION), BEING ARTICLE 20 OF THE CODE OF PUBLIC LOCAL LAWS OF MARYLAND (1930 EDITION), TITLE "SOMERSET COUNTY," SUBTITLE "COUNTY COMMISSIONERS," BE AND IT IS HEREBY REPEALED AND RE-ENACTED WITH AMENDMENTS TO READ AS FOLLOWS:

THERE SHALL BE THREE COUNTY COMMISSIONERS FOR SOMERSET COUNTY, WHO SHALL HOLD OFFICE FOR FOUR
