- (1) (2) No person DEALER shall sell, transfer, purchase or receive transfer of any pistol or revolver until after seven days shall have elapsed from the time an Application to Purchase or Transfer shall have been executed by the prospective purchaser or transferee, in triplicate, and forwarded by the prospective seller or transferer to the Superintendent of the Maryland State Police or his duly authorized agent or agents. The said Superintendent is hereby authorized to delegate the Police Commissioner of Baltimore City, the Chiefs of Police in those counties maintaining a police force, and the Sheriffs in those counties not maintaining a police force, to act as his agent or agents in the implementation of the provisions of this subtitle:
- (2) (3) The prospective seller or transferor DEALER shall promptly after receiving an Application to Purchase or Transfer, completed in accordance with subsection 4 below, forward one copy of the same, by certified mail, to the Superintendent of the Maryland State Police or his duly authorized agent or agents. The copy forwarded to the said Superintendent or his duly authorized agent or agents shall contain the name, address and signature of the prospective seller or transferor. The prospective seller or transferor shall retain one copy of the Application for a period of not less than three years. The prospective purchaser or transferoe shall be entitled to the remaining copy of the Application.
- (3) (4) The Application to Purchase or Transfer shall bear the following legend: "Any false information supplied or statement made in this Application is a crime which may be punished by imprisonment for a period of not more than three TWO years, or a fine of not more than \$1,000 or both."
- (4) (5) The Application to Purchase or Transfer shall contain the following information:
- (a) Applicant's name, address, occupation, place and date of birth, height, weight, race, eye and hair color. AND SIGNATURE. IN THE EVENT THE APPLICANT IS A CORPORATION, THE APPLICATION SHALL BE COMPLETED AND EXECUTED BY A CORPORATE OFFICER WHO IS A RESIDENT OF THE JURISDICTION IN WHICH THE APPLICATION IS MADE.
- (b) An identifying description of the pistol or revolver to be sold or transferred, including its caliber, make, model, manufacturer's number, and any other special or peculiar characteristic or marking by which the said pistol or revolver may be identified.
- (c) (B) The date and hour the Application was delivered in completed form to the prospective seller or transferor by the prospective purchaser or transferoe.
 - (d) (C) A statement by the applicant that he or she:
- (i) Has never been convicted of a crime of violence, in this State or elsewhere, or of any of the provisions of this subtitle AND WHETHER OR NOT THERE WAS A PRIOR APPLICATION MADE AND IF SO, WHEN AND WHERE.
 - (ii) Is not a fugitive from justice.
 - (iii) Is not an habitual drunkard.
- (iv) Is not addicted to the use of drugs OR ANY HABITUAL USER OF NARCOTICS, BARBITURATES OR AMPHETAMINES.
