Senate Bill No. 3—By Senator Malkus :

Subject: "ELECTIONS," subtitle "HOUSE OF REPRESENTATIVES."

Amendments to Senate Bill No. 3

By Mr. McGuirk :

Amendment No. 1—In lines 6 and 7 of the title of the third reading file bill, strike out beginning with the words "for the" in line 6 down to and including the word "Act" in line 7.

Which amendment was withdrawn by the sponsor.

Amendment No. 2—In lines 4 and 5 of Section 166B on page 1 of the third reading file bill, strike out beginning with the words "at the" in line 4 down to and including the word "only" in line 5.

Which amendment was withdrawn by the sponsor.

Amendment No. 3—Strike out all of lines 1-9, inclusive, comprising all of Section 2 on page 2 of the third reading file bill.
