

Amendment No. 3—In line 3 of Section 166E on page 2 of the third reading file bill, strike out the numerals “12” and in line 4 strike out the numerals “77” and insert in lieu thereof the numerals “46” and in the same line after the numerals “27” add the following: “and of that portion of Baltimore County within election district 12.”

Amendment No. 4—In lines 2 and 3 of Section 166F on page 2 of the third reading file bill, strike out the following: “Prince George’s County” and insert in lieu thereof the following: “those portions of Baltimore City within wards 4, 11, 12, 14, 17, 22, 23, 24, and precincts 12 through 19, inclusive, of ward 25 and precincts 47 through 81, inclusive, of ward 27 and all of Anne Arundel and Calvert Counties.”
