## REPORT OF CONFERENCE COMMITTEE ON SENATE BILL NO. 3

April 5, 1966.

To the Members of the General Assembly:

Your Conference Committee herewith reports its recommendations on Senate Bill No. 3.

The bill as passed by the Senate of Maryland was amended by the House of Delegates. The Senate refused to concur in the House amendments and asked that the House of Delegates recede from its amendments. The House of Delegates refused to recede, and your Conference Committee was appointed.
