

*the heretofore existing law, is hereby abolished, EXCEPT AS OTHERWISE ALLOWED IN THIS SUBSECTION. For the purposes of this section and of Sections 49 and 50 of this article, the term "supplementation" is defined as any additional payments from a political subdivision or political subdivisions to a judge or his widow, including but not limited to payments in the form of salary, bonus, pension, widow's benefit and expense or travel allowances.* OTHER THAN REIMBURSABLE EXPENSES ACTUALLY INCURRED IN CONNECTION WITH THE DUTIES OF HIS OFFICE AS OF JULY 1, 1967, THE SALARIES PAID TO ANY JUDGE OF THE SEVERAL COURTS OF THE EIGHT JUDICIAL CIRCUITS MAY BE SUPPLEMENTED BY ANY COUNTY OF THE CIRCUIT IN WHICH THE JUDGE RESIDES OR BALTIMORE CITY TO AN AMOUNT NOT TO EXCEED FIVE THOUSAND DOLLARS (\$5,000) PER ANNUM; AND AS OF JULY 1, 1968, THE SALARY OF ANY SUCH JUDGE MAY BE SUPPLEMENTED BY AN AMOUNT NOT TO EXCEED TWO THOUSAND FIVE HUNDRED DOLLARS (\$2,500) PER ANNUM; AND AS OF JULY 1, 1969, AND THEREAFTER ANY SUCH SUPPLEMENTATION SHALL BE ABOLISHED. IF AFTER JULY 1, 1969, ANY COUNTY OR BALTIMORE CITY SHALL SUPPLEMENT THE SALARY OF ANY OF SUCH JUDGES, THE SALARY PAID BY THE STATE TO SUCH JUDGE SHALL BE PAID IN AN AMOUNT REDUCED BY THE AMOUNT OF SUCH SUPPLEMENTATION.

F(e) (e-1) Same Judges receiving no supplementation. The salary specified in subsections (a), (a-1) and (b) shall be paid by the State in full amount to ~~any~~ all judges of such ~~courts~~ courts who receives~~s~~ no supplementation ~~for additional payments as salary (hereafter in this section referred to as "supplementation")~~ from a political subdivision~~s~~ or political subdivisions.

F(e-1) (e-2) Same Judges receiving supplementation. The salary specified in subsections (a), (a-1) and (b) shall be paid by the State in reduced amount to ~~any~~ all judges of such ~~courts~~ courts who receive~~s~~ supplementation from a political subdivision or political subdivisions. In such event, the judge or judges shall be paid annually by the State an amount computed by subtracting from the sum ~~of twenty thousand (\$20,000) dollars~~ specified in subsections (a), (a-1) and (b) a sum equal to the annual supplementation; and the amount subtracted from the State's payment to the judge shall be paid by the Comptroller to the particular political subdivision which pays such judge the supplementation; provided that, by combining the State payment and the supplementation, there shall be no reduction in the total compensation to be paid any judge~~s~~ as specified in subsections (a), (a-1) and (b).

F(e-2) Same Maximum payments to be made by State. Payments made by the State to a political subdivision or subdivisions, and/or a judge under subsection (e-1), shall not exceed for any one judge the sum of twenty thousand dollars (\$20,000.) annually. If a judge receives supplementation from two or more political subdivisions, and the aggregate supplementation exceeds twenty thousand dollars (\$20,000.) annually, the payments made by the State to the political subdivisions shall be divided between or among them in ratio to the amount of supplementation paid by each.~~s~~
