~~Sec. 2. And be it further enacted, That this Act shall take effect June 1, 1967.~~

SEC. 2. AND BE IT FURTHER ENACTED, THAT BEFORE THIS ACT BECOMES EFFECTIVE IT SHALL FIRST BE SUBMITTED TO A REFERENDUM OF THE LEGALLY QUALIFIED VOTERS OF ANNE ARUNDEL COUNTY AT THE GENERAL ELECTION TO BE HELD IN NOVEMBER OF 1968. THERE SHALL BE PRINTED ON THE BALLOTS OR BALLOT LABELS TO BE USED AT SAID ELECTION THE TITLE OF THIS ACT AND UNDERNEATH SAID TITLE, ON SEPARATE LINES, A SQUARE OR BOX TO THE RIGHT OF AND OPPOSITE THE WORDS: "FOR USE OF PUBLIC SCHOOL BUSES BY STUDENTS ATTENDING PRIVATE OR PAROCHIAL SCHOOLS" AND A CORRESPONDING SQUARE OR BOX TO THE RIGHT OF AND OPPOSITE THE WORDS "AGAINST USE OF PUBLIC SCHOOL BUSES BY STUDENTS ATTENDING PRIVATE OR PAROCHIAL SCHOOLS" SO THAT THE VOTERS OF THE COUNTY SHALL BE ABLE TO DESIGNATE THEIR DECISION FOR OR AGAINST THE PROVISIONS OF THIS ACT. IF A MAJORITY OF THE VOTES CAST IN SAID ELECTION SHALL BE "FOR USE OF PUBLIC SCHOOL BUSES BY STUDENTS ATTENDING PRIVATE OR PAROCHIAL SCHOOLS" THEN THE PROVISIONS OF THIS ACT SHALL BECOME EFFECTIVE, BUT IF A MAJORITY OF THE VOTES CAST IN THE ELECTION SHALL BE "AGAINST USE OF PUBLIC SCHOOL BUSES BY STUDENTS ATTENDING PRIVATE OR PAROCHIAL SCHOOLS" THEN THE PROVISIONS OF THIS ACT SHALL BE OF NO EFFECT AND SHALL BE NULL AND VOID.

SEC. 3. AND BE IT FURTHER ENACTED, THAT SUBJECT TO THE PROVISIONS OF SECTION 2 HEREIN THIS ACT SHALL TAKE EFFECT ON JULY 1, 1969.

CHAPTER 733

(House Bill 571)

AN ACT to authorize and empower the County Commissioners of Queen Anne's County to borrow an amount not exceeding Three Hundred Twenty-five Thousand Dollars (\$325,000.00) to finance the construction, acquisition, improvement or extension of certain public facilities as defined in this Act, by the issuance of bonds, to provide generally for the terms, procedure, and other details incident or necessary to the issuance of said bonds, and to provide for the levy of taxes to pay the interest on and to retire said bonds.
