

8. Beer license, Class A (off sale).

(k) Exceptions.—This section shall not apply to Anne Arundel County, Baltimore City, nor to Baltimore, Charles, [Garrett,] Harford, and St. Mary's counties, in all of which jurisdictions such licenses shall not be issued.

9. Beer license, Class B (on sale)—Hotels and restaurants.

(k) Exceptions.—This section shall not apply to Baltimore City nor to Allegany, Anne Arundel, Baltimore, Charles, [Garrett,] Harford, Howard and St. Mary's counties, in all of which jurisdictions such licenses shall not be issued.

10. Beer license, Class C (on sale)—Clubs.

(k) Exceptions.—This section shall not apply to Baltimore City, nor to Anne Arundel, Baltimore, Charles, [Garrett,] Harford, Kent, St. Mary's and Somerset counties, in all of which jurisdictions such licenses shall not be issued.

13. Beer and light wine license, Class A (off sale).

(k) Exceptions.—This section shall not apply to the City of Annapolis nor to Calvert, Caroline, Charles, Dorchester, [Garrett,] Howard, Kent, Queen Anne's, St. Mary's, Somerset, and Talbot counties, in all of which jurisdictions such licenses shall not be issued.

14. Beer and light wine license, Class B (on sale)—Hotels and restaurants.

(l) Exceptions.—This section shall not apply to Allegany, Calvert, Caroline, Charles, Dorchester, [Garrett,] Howard, Kent, Queen Anne's, St. Mary's, Somerset, and Talbot counties, in all of which jurisdictions such licenses shall not be issued.

15. Beer and light wine license, Class C (on sale)—Clubs.

(i) Exceptions.—This section shall not apply to Calvert, Caroline, Charles, Dorchester, [Garrett,] Kent, Queen Anne's, St. Mary's, Somerset and Talbot counties, in all of which jurisdictions such licenses shall not be issued.

16. Beer and light wine license, Class D (on sale)—Generally.

(j) Exceptions.—This section shall not apply to the City of Annapolis nor to Calvert, Caroline, Charles, Dorchester, Frederick, [Garrett,] Harford, Howard, Kent, Queen Anne's, St. Mary's, Somerset, and Talbot counties, in all of which jurisdictions such licenses shall not be issued.

18. Beer, wine and liquor license, Class A (off sale).

(o) Exceptions.—This section shall not apply to Caroline, Dorchester, [Garrett,] Harford, Kent, Montgomery, Somerset, Wicomico and Worcester counties, in all of which jurisdiction such licenses shall not be issued.
