

BEEN SOLD ON CREDIT. IT SHALL BE UNLAWFUL FOR ANY LICENSEE TO ALLOW ANY MINOR OR MINORS UNDER THE AGE OF 21 YEARS TO LOAF OR LOITER ABOUT HIS PLACE OF BUSINESS.

(B) IT IS UNLAWFUL FOR ANY LIQUOR LICENSEE UNDER THIS ARTICLE TO EMPLOY ANY PERSON UNDER THE AGE OF TWENTY-ONE YEARS AND FOR ANY OTHER CLASS OF LICENSEE TO EMPLOY ANY PERSON UNDER THE AGE OF EIGHTEEN YEARS IN THE SALE OF ALCOHOLIC BEVERAGES OR IN CONNECTION WITH THE BUSINESS THEREOF.

(C) THE MEMBERS OF THE RESPECTIVE BOARDS SHALL BE APPOINTED BY THE GOVERNOR WITH THE ADVICE AND CONSENT OF THE SENATE. PROVIDED, THAT IN SOMERSET COUNTY THEY SHALL BE APPOINTED BY THE GOVERNOR. IN HARFORD COUNTY THEY SHALL BE APPOINTED BY THE BOARD OF COUNTY COMMISSIONERS. IN GARRETT COUNTY, THE MEMBERS OF THE BOARD SHALL BE APPOINTED BY THE GOVERNOR. HE SHALL APPOINT TWO MEMBERS OF THE BOARD WHO ARE MEMBERS OF THAT POLITICAL PARTY WHICH HAS ELECTED A MAJORITY OF THE MEMBERS OF THE BOARD OF COUNTY COMMISSIONERS AND ONE MEMBER OF THE BOARD FROM THAT POLITICAL PARTY OTHER THAN THE ONE ELECTING A MAJORITY OF THE BOARD OF COUNTY COMMISSIONERS. THE APPOINTMENTS SHALL BE CONFIRMED BY THE MEMBERS OF THE HOUSE OF DELEGATES ELECTED FROM THE COUNTY IF THERE IS NO RESIDENT SENATOR ELECTED FROM THE COUNTY. IN KENT COUNTY THE COUNTY COMMISSIONERS SHALL BE EX OFFICIO THE MEMBERS OF THE LIQUOR CONTROL BOARD. IN HARFORD COUNTY SAID BOARD SHALL ALSO BE KNOWN AS THE BOARD OF LICENSE COMMISSIONERS OF HARFORD COUNTY, UPON WHICH SHALL BE DEVOLVED ALL THE DUTIES AND RIGHTS GIVEN ELSEWHERE IN THIS ARTICLE. IN MONTGOMERY COUNTY THE DIRECTOR OF THE DEPARTMENT OF LIQUOR CONTROL SHALL BE APPOINTED AND REMOVED BY THE COUNTY MANAGER WITH THE APPROVAL OF THE COUNTY COUNCIL. IF THERE IS NO RESIDENT SENATOR FROM CAROLINE COUNTY IN THE SENATE OF MARYLAND AT THE TIME OF THE APPOINTMENT, THE APPOINTMENT IN THAT COUNTY SHALL BE WITH THE ADVICE AND CONSENT OF THE HOUSE OF DELEGATES OF MARYLAND.

(A-1) IN GARRETT COUNTY THE COUNTY LIQUOR DISPENSARIES MAY BE ESTABLISHED AND MAINTAINED IN GRANTSVILLE (DISTRICT NO. 3) AND IN OAKLAND (DISTRICT NO. 7). THE DISPENSARIES ARE AUTHORIZED TO MAKE CLASS A OR "OFF-SALES" OF WINE AND LIQUOR. ALL LIQUOR AND WINES SOLD BY CLASS B AND C (ON SALE) BEER, WINE AND LIQUOR LICENSEES MUST BE PURCHASED FROM A GARRETT COUNTY LIQUOR DISPEN-
