ALSO, ANY APPROPRIATIONS ELSEWHERE IN THIS BUDGET BILL TO THE SPECIFIC ACCOUNT OF AN EDUCATIONAL INSTITUTION AND FOR SPECIFIC PURPOSES COVERED BY SENATE BILLS 320 AND 322, OR THEIR SUBSTANTIAL EQUIVALENTS, ARE SUBJECT TO THE SAME CONTINGENCY; IF SENATE BILL NO. 320 AND/OR SENATE BILL NO. 322, OR THEIR SUBSTANTIAL EQUIVALENTS IN EACH INSTANCE, ARE SO ENACTED INTO LAW, THESE APPROPRIATIONS SHALL BE APPROPRIATED INSTEAD TO AND FOR THE PURPOSES AND UNDER THE PROCEDURES IN SAID SENATE BILL 320 OR ITS SUBSTANTIAL EQUIVALENT AND/OR IN SAID SENATE BILL 322 OR ITS SUBSTANTIAL EQUIVALENT, IN EITHER OR BOTH EVENTS TO BE EXPENDED BY THE STATE SCHOLARSHIP BOARD.
