In Dorchester County, notwithstanding any other provisions of this subtitle, a Class C, beer, wine and liquor licensee shall be entitled to sell beer, wine and liquor for consumption on the premises only, between the hours of 10 o'clock A.M. on any day and 1 o'clock A.M. on the following day, except that no sales shall be made between midnight Saturday and 10 o'clock A.M. on the following Monday on Sunday, Class B, C, and D A AND C beer licensees may sell beer and Class B and C beer, wine and liquor licensees may sell beer, wine and liquor from midnight and 1:00 A.M. and 1:00 o'clock P.M. to 12:00 o'clock midnight Sundays.

SEC. 2. And be it further enacted. That this Act shall take effect June 1, 1967.

CHAPTER 337 (House Bill 956)
