WHEREAS, THE GENERAL ASSEMBLY WISHES TO KEEP THE PEOPLE OF MARYLAND FULLY APPRIZED OF THE PLANS FOR AND THE OPERATION OF A CONSTITUTIONAL CONVENTION AND FOR THIS PURPOSE ARE MAKING PROVISION HEREIN FOR AN HISTORIAN TO RECORD AND PRESERVE THE PROCEEDINGS OF THE CONSTITUTIONAL CONVENTION AND ALSO FOR AN INFORMATION SERVICE TO GIVE DAY-TO-DAY INFORMATION IN RELATION THERE-TO; NOW, THEREFORE

SECTION 1. *Be it enacted by the General Assembly of Maryland,* That, the following provisions with respect to the election of delegates to, and the holding of, a convention to frame a new constitution for the State of Maryland be, and the same are, hereby adopted.

1.

Any person shall be eligible to be a delegate to the Constitutional Convention who, at the time of his election as a delegate, is at least twenty-one years of age, is a citizen of the State of Maryland, has resided in the State for at least three years next preceding his election, and has resided in the county or the legislative district or subdistrict of the county or of the City of Baltimore from which he seeks election for a least one year next preceding his election.

A special election shall be held on Tuesday, June 6 13, 1967, for the election of the delegates to the Convention, at which there shall be elected from each county, legislative district or subdistrict thereof for the election of members of the House of Delegates, or legislative district of Baltimore City the following numbers of delegates:
