

(e) The term "beauty shop" is defined as any premises, building or part of building whereon or wherein any branch or combination of cosmetology or hairdressing is practiced.

(f) The word "manager" is defined as any person who has or has had direct supervision over cosmetologists in a beauty shop.

(g) The word "cosmetologist" is defined as any person practicing cosmetology, beauty culture or hairdressing, who is not a manager, cosmetologist aide, student manicurist, or demonstrator or wigologist; JUNIOR COSMETOLOGIST OR STUDENT COSMETOLOGIST.

(h) The word "demonstrator" is defined as any person who, for compensation, whether paid by a regular employer or not, demonstrates any beauty preparations or equipment upon a patron for profit in a beauty shop.

(i) The word "owner" is defined to be any person who shall own or lease the shop wherein beauty culture is practiced.

(j) The word "Board" means the "State Board of Cosmetologists."

(k) As described in this subtitle, the word "Cosmetologist Aide" means a person who is licensed to perform limited practices of cosmetology; namely, shampooing, removing nets, rollers, clips and pins, rinsing permanent wave lotion and removing permanent wave rods, removing hair color, sterilizing combs, brushes, nets and all necessary equipment and who is at all times under the direct supervision of the manager of said registered Beauty Salon.

(l) The word "electrologist" shall mean any person licensed to remove surplus hair by means of specially designed electric needles, and does not cover the general practice of cosmetology.

(m) The word "student" shall mean any person who is engaged in learning and acquiring the knowledge of the practices of hairdressing and cosmetology for tuition or a fee in a school duly authorized under this subtitle.

(n) The term "school of cosmetology" is defined as any premises, building, or part of a building wherein instruction in the practice of hairdressing and cosmetology is given to a student for tuition or a fee.

(o) The term "postgraduate school of cosmetology" is defined as any premises, building, or part of a building wherein instruction is given in hair styling, hairdressing or beauty culture to licensed cosmetologists, managers, teachers and/or other persons licensed by the Board for tuitions or a fee.

(p) The term "wigology" means the dressing of wigs in the practice of cosmetology and the performance of this service to the public in the practice of cosmetology. A person must be a licensed cosmetologist or a licensed wigologist to clean, dress, fix, arrange or style a wig, wiglet or hair piece made of human hair or synthetics upon a person's hair. The dressing of wigs and hair pieces shall include the fitting, styling and arranging of a wig, wiglet or hair pieces made of human hair or synthetics, upon the hair of a person, but shall not include the colling of a wig, wiglet or hair piece made of human hair or synthetics, to an individual for use over the natural hair if the wig, wiglet or hair piece made of human hair or syn-
