

thetics, is not fitted, dressed or arranged by the seller. The cleaning, dressing, fitting, styling and arranging of wigs, wiglets or hair pieces made of human hair or synthetics, may only be performed in a licensed Beauty Shop or a licensed Wig Shop. All sanitary practices required by the Board of Cosmetologists for licensed Beauty Shops must be observed in the dressing of wigs and hairpieces. Excepted from these provisions are students trained in licensed cosmetology schools who are taught the fitting, dressing, styling and arranging of wigs, wiglets and hair pieces made of human hair and synthetics, as the part of the curriculum approved by the Board.

(P) THE TERM STUDENT COSMETOLOGIST SHALL MEAN A PERSON PRESENTLY ENROLLED IN A SCHOOL OF COSMETOLOGY, WHO HAS COMPLETED 500 HOURS OR MORE OF TRAINING TO ENABLE THE PERSON TO WORK IN A REGISTERED BEAUTY SALON, PART TIME, AFTER SCHOOL, SATURDAYS AND DURING SUMMER VACATION TIME.

(Q) THE TERM JUNIOR COSMETOLOGIST SHALL MEAN A PERSON DESIROUS OF LEARNING COSMETOLOGY, BOTH THEORY AND PRACTICAL, AND IS NOT ABLE TO ATTEND A SCHOOL OF COSMETOLOGY, SAID PERSON MUST WORK FULL TIME IN A REGISTERED BEAUTY SALON FOR TWO YEARS UNDER THE DIRECT SUPERVISION OF THE SHOP MANAGER.

(a) It shall be unlawful for any person, firm or corporation to practice or teach cosmetology or manage a beauty shop, or to use or maintain any place for the practice or teaching of cosmetology or to demonstrate on any person beauty preparations or equipment for compensation unless he, she, or it shall have first obtained from the Board a certificate of registration as provided in this subtitle.

(b) Students must also obtain certificates of registration before enrollment in any school of cosmetology.

(c) Every owner of a beauty shop must apply for and secure from the Board a certificate of registration on an application to be furnished by the Board, which application shall contain the name of the senior manager of said shop, said certificate to be known as "owner's certificate" for which no examination shall be required. In the event of a change of the manager of said shop it shall be the duty of said owner to so notify the Board promptly in writing; provided, however, that in the event the owner of said shop shall also be a licensed manager, the owner's certificate shall not be required.

(d) Every owner of a school of cosmetology or a postgraduate school of cosmetology must apply for and secure from the Board a certificate of registration on an application to be furnished by the Board, which application shall contain the name of said school; said certificate to be known as a school license for which no examination shall be required. In the event of a change of the owner of said school, it shall be the duty of the new owner to so notify the Board promptly in writing.
