

CHAPTER 765

(House Bill 1342)

AN ACT to add new Section 53B to Article 2B of the Annotated Code of Maryland (1957 Edition and 1967 Supplement), title "Alcoholic Beverages," subtitle "General Provisions On Issue Of Licenses," to follow immediately after Section 53A thereof to ~~prohibit the issuance of any new licenses for the sale of alcoholic beverages except Class B licenses within the area of Baltimore City bounded by Twenty-fifth Street on the north, Center Street on the south, Howard Street on the west and Guilford Avenue on the east~~ PROVIDE THAT IN THE AREA OF BALTIMORE CITY BOUNDED BY TWENTY-FIFTH STREET ON THE NORTH, CENTER STREET ON THE SOUTH, HOWARD STREET ON THE WEST AND GUILFORD AVENUE ON THE EAST, NO NEW LICENSES FOR THE SALE OF ALCOHOLIC BEVERAGES EXCEPT CLASS B LICENSES SHALL BE ISSUED, NO LICENSES OF ANY CLASS ALREADY IN EXISTENCE SHALL BE TRANSFERRED INTO SUCH AREA OF BALTIMORE CITY, AND NO SPECIAL AMUSEMENT LICENSE SHALL BE ISSUED TO ANY HOLDER OF A CLASS D BEER, WINE AND LIQUOR LICENSE WITHIN SUCH AREA OF BALTIMORE CITY.

SECTION 1. *Be it enacted by the General Assembly of Maryland,* That new Section 53B be and it is hereby added to Article 2B of the Annotated Code of Maryland (1957 Edition and 1967 Supplement), title "Alcoholic Beverages," subtitle "General Provisions On Issue Of Licenses," to follow immediately after Section 53A thereof and to read as follows:

53B.

In Baltimore City, within the area bounded by Twenty-fifth (25th) Street on the north and Center Street on the south and Howard Street on the west and Guilford Avenue on the east, no new licenses for the sale of alcoholic beverages shall be issued except Class B licenses. AND NO LICENSES FOR THE SALE OF ALCOHOLIC BEVERAGES OF ANY CLASS SHALL BE TRANSFERRED INTO THIS AREA OF BALTIMORE CITY, FURTHER, THE BOARD OF LICENSE COMMISSIONERS OF BALTIMORE CITY SHALL NOT AUTHORIZE THE ISSUANCE OF A SPECIAL AMUSEMENT LICENSE TO THE HOLDER OF A CLASS D BEER, WINE AND LIQUOR LICENSE IN SUCH AREA OF BALTIMORE CITY.

SEC. 2. *And be it further enacted,* That this Act shall take effect July 1, 1968.
