BE FIVE THOUSAND DOLLARS (\$5,000.00) PER YEAR. THE COUNTY COMMISSIONERS OF TALBOT COUNTY SHALL PROVIDE AN OFFICE IN THE COURT HOUSE OR OTHER ACCESSIBLE PUBLIC BUILDING OF SUFFICIENT SIZE TO HOUSE THE STATE'S ATTORNEY AND HIS STAFF AND SHALL PROVIDE SUCH SECRETARIAL AND CLERICAL ASSISTANCE AS NECESSARY FROM TIME TO TIME.

(3) THE STATE'S ATTORNEY FOR TALBOT COUNTY AND ANY ASSISTANT STATE'S ATTORNEYS IN SAID COUNTY ARE HEREWITH PROHIBITED FROM REPRESENTING ANY CLIENT IN A CIVIL MATTER EITHER ON BEHALF OF THE PLAINTIFF OR THE DEFENDANT IN ANY CASE RELATED TO THE OBTENTION OR DEFENSE OF DIVORCE, SUPPORT, CUSTODY OR OTHER CIVIL MATTERS OF A DOMESTIC NATURE.

SEC. 2. And be it further enacted, That this Act shall take effect July 1, 1968.

CHAPTER 212

(House Bill 237)

AN ACT to repeal and re-enact, with amendments, Section 25(a) of Article 51 of the Annotated Code of Maryland (1964 Replacement Volume and 1967 Supplement), title "Juries," subtitle "Qualification and Selection of Jurors," to increase the pay for jurors in Talbot County.

SECTION 1. Be it enacted by the General Assembly of Maryland, That Section 25(a) of Article 51 of the Annotated Code of Maryland (1964 Replacement Volume and 1967 Supplement), title "Juries," subtitle "Qualification and Selection of Jurors,", be and it is hereby repealed and re-enacted, with amendments, to read as follows:

25.

(a) Jurors in Washington County shall receive eight dollars per day and a reasonable amount, in the discretion of the County Commissioners for each mile over five miles in going to and returning from court; in Queen Anne's and Caroline counties, seven dollars and fifty cents per day; in Anne Arundel, Harford, Kent, Montgomery [and], Somerset and Talbot counties, and in Baltimore City, ten dollars per day, and no extra allowance shall be given either for mileage or overtime in Anne Arundel, Harford, Montgomery, [and] Somerset and Talbot counties and in Baltimore City; in Carroll County, eight dollars per day; in Prince George's and Charles counties, jurors shall receive per diem compensation, not less than five (\$5.00) dollars nor more than ten (\$10.00) dollars, in such amounts as shall be set, from time to time, by the judges of the circuit court for said county and in all other counties, except Allegany, Baltimore, Calvert, Frederick,
