to the extent of any inconsistency; providing generally for the salaries payable to the several judges of this State in the Court of Appeals, the Court of Special Appeals, the several Circuit Courts in the counties and the Supreme Bench of Baltimore City, providing for the pension or salary payable to certain of these judges at the time of their retirement or otherwise and to their spouses; making provision for the powers of the several counties and of the Mayor and City Council of Baltimore in respect to these salaries and pensions, and relating generally to the salaries and pensions of the several judges and of their spouses in this State.
