

SEC. 2. *And be it further enacted*, That all laws or parts of laws, public general or public local, inconsistent with the provisions of this Act are hereby repealed to the extent of any such inconsistency.

SEC. 3. *And be it further enacted*, That this Act shall take effect June 1, 1968.

~~AN ACT to add a new Section 408A to Article 43 of the Annotated Code of Maryland (1965 Replacement Volume and 1966 Supplement), title "Health," subtitle "Water, Ice and Sewerage," to follow immediately after Section 408 thereof, providing that the Interstate Commission on the Potomac River Basin and the Upper Potomac River Commission each may extend to its employees membership in the Employees' Retirement System of the State of Maryland and providing also for the procedures and conditions applicable thereto.~~

AN ACT TO REPEAL AND RE-ENACT, WITH AMENDMENTS, SECTION 21(1) OF ARTICLE 73B OF THE ANNOTATED CODE OF MARYLAND (1965 REPLACEMENT VOLUME), TITLE "PENSIONS," SUBTITLE "EMPLOYEES OF MUNICIPAL CORPORATIONS," TO INCLUDE EMPLOYEES OF THE INTERSTATE COMMISSION ON THE POTOMAC RIVER BASIN AND THE UPPER POTOMAC RIVER COMMISSION IN THE DEFINITION OF MUNICIPAL EMPLOYEES FOR PARTICIPATION IN THE EMPLOYEES' RETIREMENT SYSTEM PURPOSES.

Section 1. *Be it enacted by the General Assembly of Maryland*, That a new Section 408A be and it is hereby added to Article 43 of the Annotated Code of Maryland (1965 Replacement Volume and 1966 Supplement), title "Health," subtitle "Water, Ice and Sewerage," to follow immediately after Section 408 thereof, and to read as follows:

SECTION 1. *BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND*, THAT SECTION 21(1) OF ARTICLE 73B OF THE ANNOTATED CODE OF MARYLAND (1965 REPLACEMENT VOLUME), TITLE "PENSIONS," SUBTITLE "EMPLOYEES OF MUNICIPAL CORPORATIONS," BE AND IT IS HEREBY REPEALED AND RE-ENACTED, WITH AMENDMENTS, TO READ AS FOLLOWS:

*The Interstate Commission on the Potomac River Basin and the Upper Potomac River Commission each may extend to its employees membership in the Employees' Retirement System of the State of Maryland. Either Commission after taking such action shall give*
