 day of in the year of our Lord 1688. At some time within the Jurisdiction of this Court was
 indebted to the said Francis in the sum of Six hundred eleven and a half pounds of tobacco as
 of a particular account of his in Court to be produced may appear. And the said Wm to the do
 Francis in manner aforesaid being indebted did assent upon himself to the do Francis fully
 promise that he the said Wm the said sum of 611 1/2 of tobacco to the said Francis would well and
 truly Content & pay. Notwithstanding the said Wm his promise and assumption aforesaid regard not
 but meaning to fraudulently intending him the said Francis in this behalf to deceive and
 defraud the said sum of 611 1/2 of tobacco. nor to the said Francis as aforesaid hath not paid but
 hath hitherto refused and doth still refuse to the damages of the do Francis of twelve hundred
