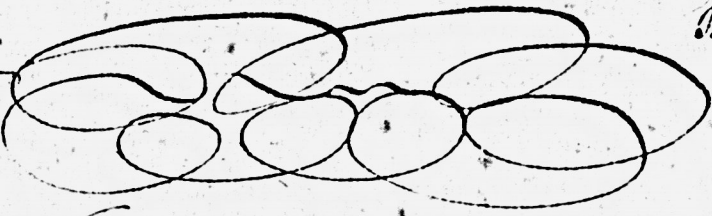

Memorandum this day being the 12 day of November 1696. This within Bond was proved
by the Oath of Francis Thoroughgood before us. The Oath. Arnold Elzy

On the back of the Bond was Writt as followeth = viz = Benjamin Deards Bond to pay
Two thousand two hundred & forty pounds of tobacco on the first of May 1694: Paid in part
of this Bond June 4. 1694 by discount of tobacco due to him the same day when was made
up and betwixt us for all works done or due betwixt us, and all goods & delivered on both
sides, the sum of eleven hundred & seven pounds of tobacco due to George Layfield of this Bond
& all due eleven hundred thirty three pounds of tobacco Witness our hands.
