 in Court sitting fail not at your peril and for your so doing this shall be your Warrant
 given under our hands this 11th day of March 1696th John Hopkino

Do hereby certify that Sarah Rockett confessed unto me that she had taken out of
 the chest belonging unto Donock Dennis the sum of twenty seven shillings in Lyon Dollars
 two of which she disposed of to Elmor Dennis for the payment of a debt she owed unto the said
 Elmor Dennis and four Lyon Dollars or pieces of eight being the value of eighteen shillings
 the said Sarah Rockett delivered unto Mary Morris for a bad debt tra the said Mary Morris
 found unto the said Sarah Rockett all which confession I do hereby confirm to be true witness my
 hand this 12th day of March 1696th Doanell Lewis

Memorandum that this 10 day of March 1696th the above deponent made oath to the said
 deposition before us
 The above said Warrant being returned the said Sarah Rockett confessed the fact whereupon the Court
 gave judgment for four shillings for her body four pieces of eight and four and that she have taken
 the said Sarah Rockett and that she be in the Sheriff's custody till she performs said judgment
 at Donock Dennis Jm

 her before our Court now sitting to answer the Complaint against her made by in Mathew Maddox that
 the said Sarah Rockett unlawfully taken from him one yard and half of Ofenburgh fail not as you
