William Morris son of Wm Morris was this day brought into Court by Thomas Quillman, where said Quillman
 shewing brought up the said Wm from a Child. It is ordered by this Court that Wm remain with said Quillman
 till one and twenty year of age.

Anthony West of the County of Somerset
 vs
 Wm Bradshaw of the County of Deccamar in Virginia of a Debt that he oweth unto him the
 sum of two thousand six hundred pounds of Tobacco & C^{ts}, whereunto he is
 indebted by a bill of exchange made the 26th day of July
 in the year of our Lord 1694. All Demands within the Jurisdiction of this Court by his Petition or writing, sealed
 the 26th day of July the said Wm Bradshaw produced may appear, he knoweth himself to be indebted to the said
 Anthony in the said sum of 2600^l pounds of Tobacco, to be paid to the said Anthony on demand, to the which payment
 well and truly to be made, the said Wm Bradshaw himself jointly by his Bond not extolled the said sum of
 two thousand six hundred pounds of Tobacco, according to the tenor of the said Bond or writing, hath not paid to the
 damage of the said Anthony of 400^l pounds of Tobacco, and the loss of his things the said sum.

The said William Coues Defendant the said & prayed the hearing of the said Bond, it is read unto
 him, he prayed also the hearing the Condition of the said Bond, it is read unto him in these words
 The Condition of this Obligation is that whereas the above bounden William Bradshaw hath sold unto the above named
 Anthony West One hundred acres of Land for the value of three thousand pounds of Tobacco & C^{ts} in hand paid & situated
 lying being in the County of Somerset in the Province of Maryland, and joining upon Land lately sold to Robert Hutchinson
 of the County of Strainat containing about one hundred & fifty acres, where said one hundred acres sold to the above said
 Anthony West. It is the said Wm Bradshaw doth here by promise and engage forthwith to gett & procure to be laid out and
 surveyed by due order and bounds, and ad firmo a Certy and assurances in the Law ad can be required, for
 the Surveying & Confirming of the before said promise, and doth hereby promise that the said Land is free from
 all incumbrances, and shall be dole to the above said Anthony West, his Heire Exors Admors or Assignes Attorneys
 for the full free of all Charge, wholly excepting paymt for Surveying if needfull, and adjudg^{ed} the said William
 Bradshaw shall cause his Wife to make a free & full renunciation of her right of dower to the said Land & that she
 had obligation to be void of none effect, otherwise to remain in full force and vertue.
