

Know all Men by these presents that I William Bradshaw of Somerset County in the Province of Maryland do owe and stand indebted unto Anthony West of the County of Annapolis in Virginia in the sum of two thousand six hundred pounds of Tobacco & Merchants according to bill of exchange to the whole payment well and truly to be made upon demand I bind my self my Heirs Executors to the said Anthony West his Heirs Executors Heirs or certain Attorney firmly by these presents Witness my hand & seal this twenty six day of November Anno 1694

The condition of said Obligation is such that whereas the above bounden William Bradshaw hath sold unto the above named Anthony West one hundred acres of Land for the value of twelve hundred pounds of Tobacco in hand paid, Situate lying & being in the County of Somerset in the Province of Maryland and adjoining upon Land lately sold to Robert Hutchinson of the County of Annapolis containing about one hundred & fifty acres. Where said one hundred acres sold to the above said Anthony West by the said William Bradshaw do hereby promise and engage forthwith to get & procure to be laid out & surveyed by due Modes & bounds, and as for in a Certificates & of records in the Law as can be required for the said making & confirming of the before recited promise. And do hereby promise, that the said Land is freed from all Incumbrances, and shall be delivered to the above said Anthony West his Heirs Executors Heirs or certain Attorney free of all charge wholly excepting payment for surveying if needfull. And also that the said William Bradshaw shall cause his Wife to make a full & full Renunciation of her Right of Herd to the said Land. That this said Obligation to be void of new effect otherwise to remain in full force & virtue.
