Sec. 2. And be it enacted, That if any butcher or other person, shall purchase any beef, cattle or hogs, brought for slaughter and sale within the corporate limits of the city of Baltimore, or within five miles thereof, which have not been weighed according to law, he shall be subject to the same penalties and forfeitures as are provided against the seller of said cattle or hogs by the 10th section of the act to which this is a supplement.
