Mr. Johnson, (seconded by two other members that voted in the majority,) moved that the House reconsider their vote upon the leave granted to the delegations of Somerset and Talbot counties, to bring in a bill to separate the collection of the county tax from the State tax, and that the same be referred to the committee on Ways and Means;

Mr. Yellott submitted the following resolution:

Resolved by the General Assembly of Maryland, That to enable the County Surveyors of the several counties in this State more conveniently to discharge the duties of their office, it shall be the duty of the levy courts or boards of commissioners of said counties respectively, to provide a suitable room, in or near the Court House of the county, for the use of said county surveyors, the expense of providing such room, if any, to be levied for and collected as other county charges.

Which was read the first time and ordered to lie on the table.

Mr. Kilgour reported a bill entitled, an act to allow Henry Harding, of Montgomery county, late sheriff and collector, further time to complete his collections.

Mr. Semmes reported a bill entitled, an act to lay out and establish a road in Prince George's county;

And Mr. Phelps reported a bill entitled, an act to repeal an act entitled, an act to lessen the expenses of Dorchester county;

Which were severally read the first and by a special order the second time and passed.

The bill reported by Mr. Yellott, chairman of the committee on Grievances and Courts of Justice entitled, an act to regulate the removal of causes for trial from one county to another, within the State;
