The House proceeded to the consideration of the order of the day, being the bill reported by him entitled, an act so to change the Constitution and Form of Government of this State, as to change Howard District, of Anne Arundel county, into a county, to be called Howard county;

Mr. Buckey moved to postpone said bill, and make it the order of the day for Monday next, 29th instant;

Determined in the negative.

Mr. Ligon then moved to withdraw said bill from the House, for the purpose of amendment;

Resolved in the affirmative.

Mr. Johnson, chairman of the committee on Ways and Means, reported a bill entitled, a supplement to the act entitled, an act to raise additional revenue to aid in paying the debts of the State, by laying a tax on salaries, incomes, emoluments and profits, passed December session 1841, chapter 325; and

Mr. Stewart reported a bill entitled, an act to amend the Constitution and Form of Government of this State, prohibiting any money being drawn from the Treasury of the State, but in consequence of appropriations made by law;

Which were severally read the first time, and severally ordered to be printed.

Mr. Fitzpatrick, (second by two other members that voted in the majority,) moved to reconsider the vote of the House, upon that part of the order, adopted on yesterday, in relation to the printing of the report of Col. Abert, to the Honorable Secretary of the Treasury of the United States, and the accompanying documents.

On the question being put,

“Will the House reconsider their vote?”

It was determined in the negative.
