Mr. Calvert moved to amend said amendment, by inserting after the word "every," in the second line the word "three," and in same line after the word "publish," inserting "once a week," also, in same line to strike out the words "not less than four," and inserting the words "the daily;"

Determined in the affirmative.

Mr. Johnson offered as a substitute for said amendment as

amended the following:

"And be it enacted, That it shall be the duty of said bank once a year for three successive years, to publish in two newspapers having a large circulation in this State, a list of unclaimed dividends and balances due depositors, not less in amount than five dollars, when such unclaimed dividends and balances have been standing for three or more years, provided, that after one publication for three successive years, the bank shall not be required to republish a list of the same balances and unclaimed dividends."

Which substitute was accepted by Mr Murray.

The said amendment was then read the second time and assent-

Mr. Wootten moved to amend said amendment, by inserting after the word "deposits," in the fourth line, the words "not less than five dollars each."

Which amendment was accepted by Mr. Murray

Mr. Murray then moved further to amend said bill by adding at the end thereof as an additional section the following:

"And be it enacted, That the offering sheet and discount list, shall at all times be open to the in spection of any stockholder."

Determined in the negative On motion of Mr. Murray,

So the amendment was rejected.

The question then recurred upon the second amendment as of-

ferred by Mr. Murray, on yesterday.

Mr. Thomas, of Talbot, moved to amend said amendment by striking out these words "nor shall it be imposed on them as a duty by the bye-laws of said bank;"
