Carroll and Cecil, and two delegates in and for each of the several counties respectively hereafter next mentioned, to wit: Kent, Queen Anne's, Talbot, Saint Mary's, Charles, Calvert and Caroline.

Sec. 2. And be it enacted, That if this act shall be confirmed, by the General Assembly next, after the next election of delegates in the first session after such new election as the Constitution and Form of Government directs that in such case, this act and the alteration therein contained, shall be considered as a part of the said Constitution and Form of Government, to all intents and purposes any thing therein contained to the contrary notwithstanding."

Which was read.

Mr. Cropper moved to lay said bill and amendment on the table; Determined in the negative.
