

Which was read the first, and by a special order the second time, and passed.

On motion of Mr. Kilgour,

Leave was granted Messrs. Kilgour, Griffith, Trundle, and Waters of Montgomery, to bring in a bill entitled, an act to allow W. O. Chappell, late sheriff and collector of Montgomery county, further time to complete his collections.

Mr. Franklin presented the petition of William McNeir, praying to be paid for certain services therein mentioned ;

Which was read and referred to the committee on Claims.

The hour having arrived for taking up the order of the day, the House again resumed the consideration of the unfinished order of yesterday, being the bill reported by Mr. Johnson chairman of the committee on Ways and Means entitled, a further supplement to the act entitled, an act for the general valuation and assessments of property in this State, and to provide a tax to pay the debts of the State, passed at March session 1841, chapter 23.

On motion of Mr. Johnson,

The House again resolved itself into a committee of the whole House upon said bill, (Mr. Chapman being in the chair,) and after some time spent in committee, the Speaker resumed the chair, and the chairman reported that the said committee had, in obedience to order, had said bill again under consideration, and having made sundry amendments thereto, had directed him to ask leave to report said bill to the House, with the amendments incorporated therein, and ask to be discharged from the further consideration thereof.

The question was then put, on concurring in the report of the committee of the whole House, and

Resolved in the affirmative.

Mr. Johnson moved that the House adjourn ;

Resolved in the affirmative.
