

And provided further, that if the said bank shall fail to pay specie on demand for its obligations, that said fact shall be considered to work a forfeiture of its charter, and the said bank shall forthwith proceed to wind up its concerns.

Which was read.

Mr. Murray moved to amend the amendment, offered by Mr. Stephenson, by striking out these words "provided and so far as the assets of said bank shall be sufficient to pay over and above the sum of its debts and common interest."

Resolved in the affirmative.

On motion of Mr. Murray,
