On motion of Mr. Ligon,

Leave was granted the committee on Grievances and Courts of Justice, to bring in a bill to cure a defect in a deed of trust executed by Ann Shipley, of Baltimore county, to Charles W. and Reuben M. Dorsey, of Anne Arundel county.

On motion of Mr. Dennis,

Leave was granted Messrs. Dennis, Waters, of Somerset, Philips and Lankford, to bring in a bill to change the name of Arnold Elzey Jones, to that of Arnold Elzey.

Mr. Potter reported a bill entitled, an act supplementary to acts passed at December sessions 1826 and 1829, relative to the appointment of bailiffs in the town of Greensborough in Caroline county ;

Which was read the first and by a special order the second time,

Mr. Keene offered as a substitute for said bill, "A bill entitled, an act authorising and requiring the levy court of Caroline county, to appoint a constable for said county, who shall reside in the village of Greensborough, in said county ;"

Which was read the first and by a special order the second time;

On the question being put,

"Will the House accept the substitute ?"

It was resolved in the affirmative.

On motion of Mr. Potter,
