

Mr. Dennis reported a bill entitled, an act to change the name of Arnold Elzey Jones, of Somerset county, to that of Arnold Elzey.

Mr. Lackland reported a bill entitled, an act to re-open a portion of the main road leading from Charles town to Perryville, in Cecil county.

Mr. Stephenson reported a bill entitled, an act for the relief of Rachel Armstrong and Angeline Purnell, of Harford county.

Mr. Temples reported a bill entitled, an act to revive an act to incorporate a company for the purpose of draining the right prong of a branch in Queen Anne's county, known by the name of the Andover Branch, passed at December session 1834, chapter 264.

Mr. Temples reported a bill entitled, an act to record and make valid a bill of sale therein mentioned ;

Mr. Carey reported a bill entitled, an act to incorporate the Maryland Historical Society ;

Also, reported a bill entitled, an act to license wood hucksters in the city of Baltimore, and to repeal the act therein mentioned ;

Mr. Chapman reported a bill entitled, an act relating to dogs, in Port Tobacco in Charles county ; and

Mr. Waters, of Montgomery, reported a bill entitled, an act to authorise the erection of a bridge over the Patuxent river, and to alter and change so much of the Columbia road as is necessary to connect said road therewith ;

Which were severally read the first and by a special order the second time, passed and sent to the Senate.

Mr. Lynch reported a bill entitled, an act to lay out and open a road through a part of Montgomery and Frederick counties ;

Which was read the first, and by a special order the second time.

Mr. Shriver moved that the bill be indefinitely postponed ;
