So the House refused to strike out the enacting clause of the bill.

Mr. Hopewell, chairman of the committee on Pensions and Revolutionary Claims, made a favorable report upon the petition of Elizabeth Hammond, widow of Peter Hammond, a soldier of the Revolution, accompanied with the following resolution:

Resolved by the General Assembly of Maryland, That the Treasurer pay to Elizabeth Hammond, or order, during her life, the half pay of a private, in consideration of services rendered by her husband during the Revolutionary war.

Which was read the first, and by a special order the second time, the report concurred in, and the resolution therein contained, assented to, and sent to the Senate.

Mr. Murrey reported a bill to change the name of William Winder Polk, to William Winder Pollock, and
