Mr. Cropper moved to amend the amendment proposed by Mr.

Powder, by striking out "fifteen" and inserting "twenty."

Mr. Poultney moved the previous question, and being demanded by a majority of the members present, the question was put, first on the amendment to the amendment, and

Determined in the negative. On motion of Mr. Potter,
