So the enacting clause of the bill was stricken out.

The bill reported by Mr. Johnson, chairman of the committee on Ways and Means, entitled, a supplement to the act entitled, an act to raise additional revenue to aid in paying the debts of the State, by laying a tax on salaries, incomes, emoluments and profits, passed at December session 1841, ch 325;

Was taken up for consideration.

Mr. Powder moved to amend said bill by adding at the end of the 8th section thereof the following proviso :

“Provided that nothing in this act shall be so construed as to apply to journeymen mechanics, weekly or daily laborers.”

Which was read.

Mr. Kilgour (being in the Chair.)

Mr. Watson (the Speaker,) moved to amend said amendment by striking out all after the word “provided,” and inserting in lieu thereof the following :

“That no salaries, incomes, emoluments, profits or remunerations in money under the sum of five hundred dollars per annum, shall be subjected to taxation under the provisions of this act or the act to which this is a supplement ;”

Determined in the negative.
