

## SEVEN O'CLOCK P. M.

The House met.

Mr. Thomas, of Talbot, submitted the following resolution :

Resolved by the General Assembly of Maryland, That the Treasurer of the Western Shore, pay to George G. Brewer, chief clerk of the House of Delegates, and Benjamin E. Gantit, assistant clerk, Joseph H. Nicholson, chief clerk of the Senate, and John N. Watkins, assistant clerk, or to their order, each the sum of one hundred dollars ; and to Harry D. Gough, Otho Shipley, John W. Rider, Robert W. Carter and William W. Le-compte, committee clerks of the House of Delegates, Joseph N. Gordon, jr. and Woolman J. Gibson, committee clerks of the Senate, or to their orders, each the sum of fifty dollars, as an extra compensation for their labors during the present session of the General Assembly.

Which was read the first and by a special order the second time ;
