(c) They shall receive an annual salary of [six thousand dollars (\$6,000.00)] ~~seventy-five hundred dollars (\$7,500.00)~~ EIGHT THOUSAND DOLLARS (\$8,000.00), with an additional annual salary of [five hundred dollars (\$500.00)] ~~twenty-five hundred dollars (\$2,500.00)~~ TWO THOUSAND DOLLARS (\$2,000.00) for the Chairman of the Board, all payable monthly by the Treasurer of said County and they are required to meet for the transaction of public business at their office at Bel Air at least one day each week, and as much oftener as the proper discharge of their official duties may require.
