They shall serve without compensation but shall be paid their reasonable and necessary expenses while engaged in the discharge of their official duties. The present members of the board shall serve ~~the~~ terms ~~for which appointed~~ of five years from the date of their appointment and these members shall each be eligible for one additional term of ~~seven~~ five years ~~;~~ except that the term expiring as of the first Monday in June, 1961, shall be filled only for a three-year period, beginning the first Monday in June, 1961; thereafter the term for this appointment shall be seven years from the first Monday in June, 1964, and the appointee holding said three-year term shall be eligible to succeed himself for one additional seven-year term~~].~~ The terms of all members appointed in ~~1960~~ 1969, and thereafter, shall be for ~~seven~~ five years from the first Monday in June of the year of appointment; ~~except that one of such terms, to be determined by the Governor, and expiring as of the first Monday in June, 1967, shall be extended for an additional three-year period, such extended term to expire as of the first Monday in June, 1970, and such appointee shall be eligible to succeed himself for one additional seven-year term. Except as herein otherwise provided, no person originally appointed to the board in 1960, and thereafter, shall serve more than two full terms.]~~ MEMBERS WHO WERE APPOINTED TO TERMS PRIOR TO JULY 1, 1969 SHALL CONTINUE TO SERVE UNTIL THE EXPIRATION OF THESE TERMS, AND UPON SUCH EXPIRATION SHALL EACH BE ELIGIBLE FOR REAPPOINTMENT. THE TERM OF OFFICE OF ALL MEMBERS APPOINTED AFTER JULY 1, 1969 SHALL BE FIVE YEARS AND SHALL EACH DATE FROM THE FIRST MONDAY IN JUNE OF THE YEAR IN WHICH APPOINTED. NO PERSON SHALL SERVE FOR MORE THAN TWO CONSECUTIVE TERMS. MEMBERS appointed to fill vacancies occurring during a term shall serve for the remainder of the term, and they shall be eligible for reappointment. ~~to two full terms of the board.~~ Three members shall be selected from lists of nominees, which shall be submitted to the Governor by the Maryland Agricultural Commission and shall contain the names of at least two nominees for each office to be filled.

SEC. 2. *And be it further enacted,* That this Act shall take effect July 1, 1969.

CHAPTER 616  
(Senate Bill 676)

AN ACT to repeal and re-enact, with amendments, Section 149A (b) of Article 43 of the Annotated Code of Maryland (1965 Replacement Volume and 1968 Supplement), title "Health," subtitle "Practitioners of Medicine," to provide that members or employees of fire departments or ambulance and rescue squads must complete both basic and advanced Red Cross or equivalent first aid courses to be eligible for exemption from liability for damages as provided in this section.
