SECTION 1. *Be it enacted by the General Assembly of Maryland,* That Section 40(t)(1) of Article 10 of the Annotated Code of Maryland (1968 Replacement Volume), title "Attorneys at Law and Attorneys in Fact," subtitle "State's Attorneys," be and it is hereby repealed and re-enacted with amendments to read as follows:

40.

(t) In Somerset County, (1) the State's Attorney's salary is [twenty-four hundred dollars (\$2,400] *six thousand dollars (\$6,000).*

SEC. 2. The provisions of this Act shall not be construed to extend or apply to the State's Attorney in office on the effective date of this Act, but these provisions shall take effect with the beginning of the next term of office.

SEC. 3. *And be it further enacted,* That this Act shall take effect July 1, 1969.
