Section 1. BE IT ENACTED BY THE COUNTY COUNCIL OF BALTIMORE COUNTY, MARYLAND, (five members thereof voting in the affirmative) that Sections 18-3, 18-11, 18-12.1, 18-13, 18-14, 18-15, 18-16, 18-17, 18-18, 18-20.1, 18-28, 18-29, 18-29.2, 18-29.3, 18-33(b), 18-35, 18-37, 18-39, 18-42, 18-43, 18-44, 18-48, 18-49, 18-50 and 18-51(a) of the Baltimore County Code, 1958 as amended, Title "Motor Vehicles and Traffic," be and they are hereby repealed and re-enacted with amendments to read as follows:

18.3. Obstruction of drivers' view at street intersection.

Whenever the county shall be advised in writing by the chief of the county Police [bureau] Department or the [roads] traffic engineer of the county that any trees, bushes, vines, fences, signs or other obstructions are located on any property at any intersection of any highways or
