In addition to the amounts provided in Section 160 to be paid to the several fire departments, fire companies, and hose companies, the County Commissioners may pay an extra sum not to exceed five hundred dollars (\$500.00) annually to each department and company except the Cumberland Hose Company. Payments under this section shall be equal and uniform for all the departments and companies. The provisions of Section 161 apply to any payments made under the provisions of this section.】
