MILITARY RESERVATION WESTERN BOUNDARY LINE ON THE SOUTH, THE DISTRICT TRAINING SCHOOL BOUNDARY LINE ON THE EAST AND THE BALTIMORE AND OHIO RAILROAD LINE ON THE NORTH, EFFECTIVE UNTIL JUNE 30, 1971, and excepting the remainder of Anne Arundel County and the city of Annapolis from the provisions of this law.

SECTION 1. Be it enacted by the General Assembly of Maryland, That Section 28(i) of Article 2B of the Annotated Code of Maryland, (1968 Replacement Volume), title "Alcoholic Beverages," subtitle "Local Licenses and License Provisions," be and it is hereby repealed; and that new Section 28(i) be and it is hereby enacted in lieu thereof, to stand in the place of the section repealed, and to read as follows:

28.

That no new licenses for the sale of alcoholic beverages of any type shall be issued OR CHANGED IN CLASSIFICATION, nor shall any other existing license for sale of alcoholic beverages be transferred to or for, any property in First Precinct of the Fourth Election District of Anne Arundel County according to the boundaries defined and established by the Board of Supervisors of Elections of Anne Arundel County as of January 1, 1966, THAT DISTRICT IN ANNE ARUNDEL COUNTY DESCRIBED AS FOLLOWS: BEGIN-NING FOR THE SAME AT A POINT LOCATED ON THE NORTH SIDE OF MARYLAND ROUTE 198 WHERE THE SAME IS INTERSECTED BY THE BOUNDARY LINE OF THE FORT GEORGE G. MEADE MILITARY RESERVATION; THENCE LEAVING SAID MARYLAND ROUTE 198 AND RUNNING WITH THE MEANDERINGS OF THE OUTLINES OF FORT GEORGE G.
MEADE MILITARY RESERVATION IN A WESTERLY DIRECTION AND SOUTHERLY DIRECTION AND SOUTHERLY DIRECTION AND SOUTHERLY DIRECTION TO ITS INTERSECTION WITH THE COUNTY LINE BETWEEN ANNE ARUNDEL COUNTY AND PRINCE GEORGE'S COUNTY; THENCE LEAV-ING THE FORT GEORGE G. MEADE RESERVATION LINES AND RUNNING WITH SAID COUNTY LINE IN A GENERAL NORTH-WESTERLY DIRECTION TO THE INTERSECTION FORMED BY THE COUNTY LINES OF PRINCE GEORGE'S COUNTY, ANNE ARUNDEL COUNTY AND HOWARD COUNTY; THENCE LEAVING PRINCE GEORGE'S COUNTY AND RUN-NING WITH THE COUNTY LINE BETWEEN ANNE ARUNDEL COUNTY AND HOWARD COUNTY IN A GENERAL NORTH-EASTERLY DIRECTION TO WHERE SAID COUNTY LINE IS INTERSECTED BY THE NORTH SIDE OF MARYLAND ROUTE # 32; THENCE LEAVING THE COUNTY LINE BETWEEN ANNE ARUNDEL COUNTY AND HOWARD COUNTY AND RUNNING WITH THE NORTH SIDE OF MARYLAND ROUTE # 32 IN A SOUTHEASTERLY DIRECTION TO WHERE THE EXTENSION OF THE PROPERTY LINE OF THE DISTRICT TRAINING SCHOOL INTERSECTS THE NORTH SIDE OF MARYLAND ROUTE # 32; THENCE LEAVING SAID MARY-LAND ROUTE # 32 AND RUNNING WITH THE LINES OF THE DISTRICT TRAINING SCHOOL IN A SOUTHWESTERLY DIRECTION TO THE NORTH SIDE OF MARYLAND ROUTE # 216; THENCE WITH THE NORTH SIDE OF MARYLAND
