In accordance with Section 17 of Article II of the Maryland Constitution, I have vetoed today House Bill 963 and am returning it to you.

This bill would authorize the Mayor and City Council of Baltimore to create a debt in the amount of four million dollars. The measure is a duplicate of Senate Bill 456 which has been signed and is now Chapter 571 of the 1968 Laws of Maryland.
