MESSAGE FROM THE HOUSE OF DELEGATES

The Chief Clerk of the House of Delegates appeared and delivered the following message:

Senate Bill No. 332—By Senators Clark, James, Dean, Hart, Nock, Steffey, Crawford and Hodges:

An Act to add new Section 369A to Article 27 of the Annotated Code of Maryland (1967 Replacement Volume), title "Crimes and Punishments," subtitle "Lotteries" to follow immediately after Section 369 thereof, pro-
