AN ORDINANCE to repeal and re-enact, with amendments, Section 6-100 of the Anne Arundel County Code (1967 Edition and Supplements), Title 6, "Crimes and Punishments", Subtitle 1, "Generally", ~~permitting~~ PROHIBITING the sale and consumption of alcoholic beverages on county owned property (except the courthouse) ~~when authorized pursuant to a contract with Anne Arundel County.~~ FOR THE SALE AND CONSUMPTION OF BEER ON THE GENERAL'S GOLF COURSE).

Section 1. BE IT ENACTED BY THE COUNTY COUNCIL OF ANNE ARUNDEL COUNTY, MARYLAND, That Section 6-100 of the Anne Arundel County Code (1967 Edition and Supplements), Title 6, "Crimes and Punishments", Subtitle 1, "Generally", be, and it is hereby repealed and re-enacted to read as follows:

Section 6-100

The consumption of alcoholic beverages upon the courthouse premises ~~is prohibited.~~ [and] ~~Except where otherwise authorized pursuant to a contract with Anne Arundel County, alcoholic beverages may not be sold or consumed~~ on any other premises owned and utilized for and on behalf of the county at any time, including the holiday season. ~~is~~ prohibited (EXCEPT FOR THE SALE AND CONSUMPTION OF BEER ON THE GENERAL'S GOLF COURSE) and anyone ~~Anyone~~ violating any of the provisions of this section shall be subject to suspension or removal from their employment with the county.

Section 2. AND BE IT FURTHER ENACTED, That this ordinance shall take effect forty-five (45) days from the date it becomes law.
