- [5] (4) Nothing contained herein shall be construed to permit the county to waive the special water and special wastewater benefit charge as set forth in section 17-608 or the area benefit charge as set forth in section 17-610.
- (d) Any person who shall be liable for, or who shall have paid, an area service charge under the Sanitary Commission Act or a capital connection charge shall be entitled to recover an amount equal to such [area service] charge, after its payment, by one or more annual credits against [the area benefit] the charge for which he shall be assessed hereunder.

Section 2. AND BE IT FURTHER ENACTED, That this Ordinance shall take effect forty five (45) days from the date it becomes law.

SECTION 2. AND BE IT FURTHER ENACTED, THAT THIS ORDINANCE IS HEREBY DECLARED TO BE AN EMERGENCY ORDINANCE AND NECESSARY FOR THE IMMEDIATE PRESERVATION OF THE PUBLIC PEACE, HEALTH, SAFETY, WELFARE AND PROPERTY AND BEING PASSED BY THE AFFIRMATIVE VOTE OF FIVE MEMBERS OF THE COUNTY COUNCIL, THE SAME SHALL TAKE EFFECT FROM THE DATE IT BECOMES LAW.
