An Ordinance to repeal Section 1-215 of the Anne Arundel County Code (1967 Edition and Supplements), Title 1, "Administration", Subtitle 2, "Personnel", Article II, "Classified Service", as last amended by Bill No. 11-69 and to enact new Section 1-215 in lieu thereof, to stand in the place of the section repealed, generally revising the classes of positions within the classified service, their titles and pay grades; to add new Sections 1-215.1 and 1.215.2 to said Code, Title, Subtitle and Article to follow immediately after Section 215 thereof, as last amended by Bill No. 11-69 clarifying existing standards for work weeks; to repeal Section 1-216 of said Code, Title, Subtitle and Article and to enact new Section 1-216 in lieu thereof, setting forth new annual and hourly pay schedules; to add new Section 1-217 (23A) to said Code, Title, Subtitle and Article, to follow immediately after Section 1-217 (23) thereof, as amended by Bill No. 7-68, setting forth qualifications for a Project Administrator; to repeal and re-enact with amendments, Section 1-217 (38) of said Code, Title, Subtitle and Article, as amended by Bill No. 7-68, changing the qualifications for a Management Analyst; to repeal Sections 1-217 (49) and (50) of said Code, Title, Subtitle and Article and to enact new Section 1-217 (49) in lieu thereof, to stand in the place of the sec-
