 Pace Also thirty two head of Horned Cattle markt with a Cropp and hole
 in the Left year and two flits in the Right Ear Also thirty head of Hogs
 of the same mark and Eighteen head of Sheep All which Cattle Hogs and Sheep
 I do upon his the said Benjamins Land in Prince Georges County do have
 & to hold all the aforesaid to be granted Lands and tenements with
 their Appurtenances unto him the said John Tailor his heirs and assignes for
 ever to the only proper use and behoof of him the said John Tailor his heirs
 assignes for ever and to none other use intent or purpose whatsoever and
 also to have and to hold all the before mentioned Negroes Goods & Chattles with
 their and every of their Incomes unto him the said John Tailor his executors
 Adm^rs & assignes forever as his and their own proper Good and Chattles
 And the said Benjamin doth hereby for himself and his heirs Executors
 and Adm^rs covenant promis^e grant and Agree to and with the said John
 Tailor his heirs Executors Adm^rs and assignes That he the said Benjamin
 at and before the sealing and Delivering of these presents is and stands
 lawfully Seised of a good Sure indefeasible Estate of Inheritance in full
 and unto the aforesaid several tracts of Lands and promises with their Appurte-
 nances and that he the said Benjamin now hath in himself good Right full
 power and Absolute Authority to alien^e Bargaine Sell and convey the same
 Lands and promises and Also the goods and Chattles aforesaid unto him the
 John Tailor his heirs Executors Adm^rs and assignes in Manner as and
