 as of this De<sup>ft</sup> and the s<sup>d</sup> Sam<sup>l</sup> Johnson did severally  
 subscribe their Names as Witnesses thereto And that the  
 Name Walter Hoxton now appearing as a Witne<sup>s</sup> thereto  
 is of this De<sup>ft</sup> s<sup>d</sup> own proper hand writing
